The hidden cost of manual freight auditing


Many companies still rely on internal teams or basic TMS tools to manage freight audit processes. - Companies using manual audit processes face 3x higher operational costs¹

- 30% of payments processed via legacy systems are late, damaging carrier relationships4

Why TMS audit capabilities fall short

Modern Transportation Management Systems are essential for planning, routing, carrier execution and visibility. Many TMS platforms also offer basic audit tools. A TMS may validate rates or flag mismatches, but it cannot:

- Handle detailed cost allocation across multiple GL codes
- Manage parcel credit recovery or freight claims
- · Handle invoice and audit exceptions
- · Ensure frequent accruals of unbilled shipment
- Support detailed financial audit compliance

For large, multimodal shippers, these limitations result in overpayments, delayed reporting and underutilized transportation data. That's where dedicated Freight Audit and Payment (FAP) solutions come in.
